Enrollment numbers will be updated after Wednesday-turnout at initial registration wasn't good; opening day today with the staff-new staff was introduced; tomorrow Authentic Literacy in-service; staff dinner Monday, August 25th at the Stag-R-Inn at 6:30-RSVP to the office; received 2nd tax payment from Logan County.

Old Business – Information

- a. Summer Maintenance Update
 - a. The summer maintenance crew did a great job-a lot was accomplished as repairs were made and the building looks nice
- b. Preliminary ISAT/PSAE Results
 - a. School report card will be released October 31-can't do comparisons but we had definite increase; have a "plan" to working with 6th grade teacher Jessica Hartman to improve scores-1st time in 3 years that the grade school out-performed the junior high; Authentic Literacy has helped-we will not see huge improvements over a single year; PSAE math outscored reading and English.
- c. Fiscal Year 2015 Budget
 - a. In the summary handed out-General State Aid lost \$73,000-declining enrollment is one factor; Ed Fund \$105,000 less in revenues; Transportation \$30,000-\$35,000 less; going to apply for another maintenance grant; Budget Hearing prior to next month's meeting.
